You don't have to be stuck with your unwanted Mazda. The California Lemon Law, also known as the Song-Beverly Act, protects all consumers who have either bought or leased a lemon car. The California law offers the manufacturer an opportunity to buy back the affected vehicle, provide the consumer with a new car of equal value or offer cash compensation to the consumer.

The Federal law, known as the Magnuson-Moss Warranty Act, also ***protects the consumer by holding manufacturers accountable*** for their cars whenever they ***fail to comply with any written promise or standards in their warranty.*** If a manufacturer sells an unsafe, dangerous, or defective vehicle to you, the law allows you to ***file a lemon claim***, and the **California Lemon Law Attorneys are here to help you.**
