## California Lemon Law

---

***The lemon law applies if the defect significantly affects the vehicle's value, safety, and use.*** The defect has to be identified before the manufacturer's warranty period lapses. However, if the defects you currently experience on your Saab first arose within the manufacturer's warranty period and they were unsuccessful in resolving them, you could be entitled to compensation even if the warranty period has expired.
