Some of the Most Common Problems of Harley-Davidson Lemons

While there are many manufacturer's defects that could qualify under lemon laws, some of the most common problems experienced by Harley-Davidson owners include:

- Batteries that require consistent replacement
- Clutch failure and replacement issues
- Cam tensioners that wear out early
- Consistent stalling
- Overheating

What is the California Lemon Law?

After the purchase or lease of your Harley-Davidson, the motorcycle will be covered under the manufacturer's warranty for a set period. If during this time your car presents significant issues or repairs that limit the functionality or safety of the motorcycle, it could be covered under the California Lemon Laws. If deemed a lemon under California Law, the manufacturer may be required to provide you with compensation.

To qualify for possible compensation under the state of [California Lemon Laws](#), your motorcycle must meet at least one of the following criteria.

- The motorcycle has had four or more repairs for the same problem when it was under the manufacturer's warranty.
- There were at least two repair attempts for defects that are considered safety defects that could have caused death or serious bodily injury. This needs to have occurred while the motorcycle was under factory warranty.
- The motorcycle was out of service for at least 30 cumulative days while under the manufacturer's warranty.
